


ORGANOGRAM


College Development Committee (CDC)

Various functions and responsibilities of the CDC are:


- Prepare the budget and financial statements.



- 2. Teacher Representative Dr. Prerana Ratnaparkhi suggested a dress code for students. Student Representative Shri Prashant Mahalle was advised to take students' opinion on the matter.
- 3. Student Representative Shri Prashant Mahalle suggested that the cycle stand charges be taken from all students. He was, however, made aware of the fact that not all students bring bicycles to college, and that charging them would be unfair. Similarly, Shri Mahalle also demanded that the college provide I Cards to all students. This demand was accepted.
- 4. Non Teaching Staff representative Shri Ajay Acharya suggested that Rs. 50 be charged to students for processing of online Enrolment Forms and Exam forms. The committee opined that this would need further discussion and that he will be informed accordingly when the decision had been reached
- 5. A committee for a hike in pay for daily workers was constituted. The committee members were Dr. J.K. Mahajan (Coordinator), Dr. C.A. Dixit (Member), and Shri Ajay Acharya (Member)


